



Loans

The rules governing the award of BAföG-loans to international students, especially non-EU students, are very complicated (§8 BAföG). To determine your eligibility, please contact your lender or the BAföG Amt.

Federal Training Assistance Act (BAföG)

A BAföG-loan is a monthly loan of up to €735 (as of April 2019) of which 50% must be repaid in instalments once the maximum period of assistance has ended. Please note: age and income restrictions apply.

Those eligible for support include: German nationals, recognized refugees, EU citizens who have been in Germany for at least five years or persons married to an EU national, non-EU nationals who worked for five years in Germany before starting to study and who hold a settlement permit (Niederlassungserlaubnis) or a permanent residence permit (Daueraufenthalt-EU), and EU students who are working in Germany.

Bildungskredit and Studienkredit

If you are in the later stages of your study programme, you can apply for a student loan from the German government and the state-owned bank KfW. Eligibility rules are the same as for BAföG loans.

Wohngeld (Housing benefit)

Financial hardship refund for the semester ticket

Students who are experiencing exceptional financial hardship can apply to Saarland University's General Student Committee (AStA; Building A5.2) to have the price of their semester travel ticket refunded.

Refund of the administrative charge

In certain cases, students may be eligible for a refund of the $\ensuremath{\mathfrak{c}}50$ administrative fee that is part of the semester fee payment. Grounds for a refund include: caring for children or close relatives, receiving financial support for educational needs (BAföG), early deregistration.
